Evansville Branch NAACP Education Committee to Host 2025 Town Hall on New Indiana Education Laws

Evansville, Indiana — The Evansville NAACP Indiana Education Committee is convening a critical Town Hall Meeting on Thursday, September 11, welcoming educators, parents, students, policy-makers, and community leaders to engage in an open, informative dialogue about the sweeping education reforms recently enacted by the Indiana General Assembly in July 2025. Confirmed panelists include Representative Alex Burton, EVSC Superintendent Darla Hoover, Senator Vaneta Becker, Rev. Melissa Morehead, and EVSC Board President Karen Ragland.

According to Evansville Branch NAACP President, Ed Lander, "Attending school board meetings and council meetings is like being in someone else's environment. We're intentionally having the meeting in a local Black church. It's a place where people can feel very comfortable, regardless of their background.

Perhaps they don't receive all the answers they want, but they have an open and honest dialogue, and they feel confident that the new school superintendent, school board members, Senator Becker, and Representative Burton are being open and transparent with them. This is just a starting point."

What's Changing in Indiana Education:

The 2025 legislative session produced a sweeping array of education-related changes, many of which take effect in the 2025–26 school year:

- Over two dozen K–12 education laws are set to go into effect on July 1, 2025, including adjustments to classroom instruction, attendance policies, teacher compensation, and budget allocations ([Indiana Capital Chronicle](#), [Yahoo News](#))
- Repeal of the ethnic studies course requirement in high schools—a sudden change made during the final stages of legislative negotiations ([Axios](#)).

- A shift to partisan school board elections, for the first time in Indiana's history ([Axios](#)).
- Reintroduction of A–F school accountability grades, albeit in a revised format ([Axios](#)).
- Expansion of the private school voucher program to all families—a controversial move amid state budget constraints and critiques that it may undercut resources for low-income students ([Axios](#)).
- Mandates for fetal development education in sex ed, relaxed student transfer rules, and faster reporting of bullying ([Mirror Indy](#))
- Removal of DEI language and instruction from educational institutions and state agencies ([Mirror Indy](#), [NAACP 3053 Website](#), [NAACP](#), [Wikipedia](#)).
